## BREEDING CONTRACT

1. I hereby agree to breed \_\_\_\_\_ age \_\_\_\_\_

My mare will not be bred unless booking fee is paid.

2. It is agreeable to check my mare for normal breeding condition, and to render any treatment or immunization that may be necessary. The expense of this service is to be added to my account.
3. It is further agreed that should the above named stallion die or become unfit for service this agreement will become null and void, and a full refund will be made. If my mare should die or become unfit to breed, then a substitute mare can take her place under the same conditions of this contract.
4. It is my understanding that you or your representative will not be responsible for accident, sickness, or death to my mare or foal, and that you and your representative will exercise your best judgement in caring and supervising for her. I will likewise not be responsible for any accident or injury to your stallion or mares.
5. Mare's registration papers or photocopy must be returned with this contract to stallion owner.
6. It is also agreed that you guarantee a live foal, or a live color foal on regular registry paint mares (no breeding stocks). For this purpose, a live foal is defined as one that stands and nurses after foaling. This guarantee will apply only if notified within forty-eight (48) hours from death. This notice must be accompanied by a statement from a licensed veterinarian. Also, the color guarantee is as follows: you will be guaranteed a color foal on paint mares only, with the limit of two breedings. Not unless the color foal is DOA at the second delivery. Upon notification of the foals color status, if the foal did not color then you will receive a rebreed at your/mares first available time. If the stallion is not standing at the same location within commuting distance as before, then shipped semen will be offered and will be sent to you by a veterinarian or a collection specialist. The mare owner will be responsible for the cost of collection and shipment, but no additional handling fees. Mare owner will retain all foals.

7. Board \$5.00 per day dry and \$6.00 per day wet

IT IS UNDERSTOOD THAT MY MARE WILL NOT BE RELEASED UNTIL SUCH TIME AS ALL VETERINARY EXPENSES, BOARD BILLS AND ANY OTHER CHARGES INCURRED ON BEHALF OF SAID MARE OR MARES HAVE BEEN PAID, AND STALLION FEE WILL BE DUE AND PAYABLE ON OR BEFORE THE MARE IS PICKED UP.

8. Should mare owner fail to deliver said mare on or before June 1, of the breeding year to the premises where said stallion is standing for the purpose of breeding said mare, the stallion owner shall be under no further obligation with respect to any matter herein set forth.

9. This contract shall not be assigned or transferred by the mare owner without stallion owner consent.

10. Negative Coggins Test required within 120-days of arrival.

11. If the mare is a repeat breeder, the only additional cost that will be incurred is the mare care or collection fee if requesting shipped semen.

12. All mares sent for breeding must be halter broke, have no rear shoes and a clean breeding culture certificate from vet within 60 days.

**13. One Thousand dollars (\$1000.00) will be given to the first foal his/her foaling year to receive an APHA /AQHA World Championship and Five hundred (\$500.00) for a Reserve Championship. The money will be presented to the owner not the exhibitor.**

Regarding Cooled Transported semen: We are trying to make this available to as many mares as possible. The fee for this service is **approximately** an additional \$250.00. This fee covers vet expense of the collection and preparation of the semen and shipment within the USA. Both the collection fee and stud fee will be paid in full before semen is shipped. There is also a \$250.00 refundable deposit on the semen container. The deposit will be returned immediately upon the return of the container. If a disposable container is used, the container will be at the mare owner's expense.
